**The report:**

The Management Board of Dom Development S.A. with its registered office in Warsaw (the “Company”), acting pursuant to § 38 par. 1 item 2) of the Regulation dated 19 February 2009 on current and interim reports published by issuers of securities, and the terms and conditions of finding as equivalent the information required under the law of a non-member state (Journal of Laws of 2014, item 133), hereby informs that the amendments to the Statute of the Company, resulting from the resolution No. 04/11/14 of the Company’s Management Board regarding the increase of the share capital through the issuance of series T shares within the scope of the authorised capital, and full and complete waiver of the pre-emptive rights of the existing shareholders, dated 18 November 2014 (the Company notified of the above-mentioned resolution in the current report No. 31/2014 dated 18 November 2014, while the amendments to the Statute were notified in the current report No. 32/2014 dated 18 November 2014), were registered with the District Court for the Capital City of Warsaw in Warsaw, 12<sup>th</sup> Commercial Division of the National Court Register on 14 January 2015.
